Kangen Air Q & A

1. Definition of Identities

Kangen Air Distributor – Not registered Distributor or User of Enagic when the Initial purchase is Kangen Air. Enagic Distributor – Registered as Enagic Distributor with machine/Ukon purchase.

2. How much does Kangen Air cost?

Standard price is SGD 2,027.40. (Price excluded delivery cost)

3. How much is an Kangen Air commission point?

Kangen Air Distributor sponsor customer to purchase Kangen Air can earn SGD\$51.

Enagic Distributor sponsor customer to purchase Kangen Air can earn SGD\$93.

If you only purchase Kangen Air products and become a distributor, you will only receive **half (50%)** commission when you sponsor others to purchase any products.

After Kangen Air product distributors purchase Enagic products themselves, commissions can be collected in **full** (100%).

4. Can I buy Kangen Air as many as I want?

Allow one unit be distributor registration while extra 4 units be user registration.

5. Can Enagic distributors purchase Kangen Air to create a new distributor account with sponsor?

Enagic distributors purchase Kangen Air to create a new distributor account, the sponsor must be himself/herself. The User registration can be sponsor by himself/herself or the original direct sponsor.

6. Can I use Kangen Air to step up?

Yes, can step up 2A-6A.

7. How does Kangen Air count for Bonus?

Kangen Air for bonus and the 6A upgrade month will be calculated at 1 sale.

8. How does SP work with Kangen Air?

Yes. Kangen Air program allow Distributors maintain their SP status for 3 months.

9. Is Kangen Air's commission status the same as Water Machine?

Kangen Air only has basic commission, no SP partial commission.

D1 (more than 3 months-within 6 months) - 100%

D0 (more than 6 months – within 1 year) - 50%

FAO (more than 1 year) - 0%

10. How long is the warranty period of Kangen Air?

Kangen Air warranty period is 1 year only.
