### Sales Count

- ❖ FC1 Filter 50 Set purchases are counted as one (1) unit sale for 6A2 & Above.  
FC1 Filter 30 Set purchases are counted as one (0.5) unit sales for 6A2 & Above.  
※The registration date of the 2<sup>nd</sup> FC1 Filter Set purchase will be the day the sale is counted as (1) unit sale for 6A2 & Above.
