Consignment Agreement

This consignment contract is executed between Enagic Singapore Pte Ltd and the respective Enagic Distributors.

I hereby would like to consign ____ Unit(s) of **K-8 / SD 501 / SD 501-PT / Super 501 / JR IV / Anespa DX / EmGuarde** bearing the **S/No.** _____/_____/_____/_____/_____ and will submit all purchasing orders and payment to Enagic Singapore Pte Ltd within **30 Days** for Machines and **14 Days** for EmGuarde for processing.

Enagic Singapore Pte Ltd will require the Distributor to settle the consigned product if no sales are submitted within the consigning period by one of the methods below if the product cannot be sold within the consigned time period:

1. Return the machine back to office in its original packaging and the seal sticker must not be torn or full payment if the seal is found to be torn.
2. Pay the full amount of the machine(s) either by single payment or credit card instalment.

Compliance Regulations for Consignment of products:

Clause:

A. Each Distributor can only consign the **approved maximum units of machines** as per the diagram below regardless of the number of Distributor IDs he/she have registered in the system with the company.

3A TO 5A	1
6A TO 6A2-2	3
6A2-3 and above	5

Only 6A2-2 and above are able to consign EmGuarde.

B. The Distributor will be barred from consigning any machine or EmGuarde for **30 days** after settling the overdue consignment or barred from consigning till further notice as decided by the company management at its discretion with the rights not to disclose the reasons.

C. Extension of ONE (1) month per unit after the 30 days will **ONLY** be applicable for machines that has made **FULL payment at the date of consignment** stated on this form or within the consignment period. If fail to settle the paid consignment unit after 60 days, it will be termed as self-purchase under the consignee. Thus, there will be no refund or grace period given.

D. A compulsory late consignment fee of SGD \$50 applies for per unit not returned to office after 30 days for non-paid and 60 days for paid consignment units under clause C. There will be no offset, refund or grace period given.

For Emguarde

*A Compulsory late consignment fee of SGD \$50 applies for per unit returned to office after 14 days for non-paid and paid consignment units under clause C. there will be no offset, refund or grace period given.

E. Enagic Singapore Pte Ltd reserves the rights at any time to hold the Distributor's bonuses and 8 points system should the Distributor has failed to register or return the consigned machine(s) or Emguarde(s) within stipulated time.

Enagic Singapore Pte Ltd will contact the Distributor for the consignment units before due date via one of the communication channels provided above as a form of Reminder/Warning.

All intellectual property rights and all licensable rights under Enagic Singapore Pte Ltd. In case of any dispute, the decision of Enagic Singapore Pte Ltd should remain final.
